TOWN MEETING NOVEMBER 13, 1989

The meeting was called to order, with a quorum of residents present, by the Town Chairperson Sue Coburn.

1. Election of Town Officers

TOWN CHAIRPERSON	Chris Cuttance

2. Storm Water Drainage Project - East Mall
A "plan package regarding an Engineering Dept Report is involved. The report on this project was not available.

3. Ordinance/NCC Zoning Authority (1st Reading)
After discussion, this Resolution was voted and passed, requesting NCC to continue their responsibilities to enforce the zoning codes.

4. COMMITTEE REPORTS

✓ MEMORIAL GARDEN - Betty Solway Smith presented a ground plan showing the location proposed, & reporting on the regulations considered necessary for establishment & continuance of this project.

✓ REGISTRATION COMMITTEE - Sherry Phalen responded to a request for information, that there exists a list of residents eligible to vote at Town Meetings.

✓ SAFETY COMMITTEE - Pat Phalen reported a suggestion that Stop Signs be placed at crucial points on Harvey Road as a measure to prevent auto accidents.

✓ LIASON COMMITTEE - Joseph Bell reported that there is reluctance to advance the process of providing for amendments to the Deed of Trust.

Budget ✓ FINANCIAL COMMITTEE - Consideration of an adjustment of the Fiscal Year date was suggested.

✓ PATHS COMMITTEE - Lisa Riblett reported research activity & enthusiasm to pursue the project of mapping & improvement.

5. Proposal for election of a 7 member Committee, elected in alternate years, merging the Civic, Planning & Safety Committees, to result in a strong active Civic Committee.

6. SPRING TRASH PICK-UP scheduling was supported.
