GUEST SPEAKER: WAYNE SMITH, STATE REPRESENTATIVE

Wayne spoke about a possible traffic light at Harvey and Sconset. State has a lot of rules to qualify for a new traffic signal. Bard spoke about possibility of getting an "on demand light". Hardy noted that Veale/Harvey is also dangerous. Hardy suggested at least street light there. Tom Nelson suggested a three way stop sign at Veale and Harvey. Doris and Page (Civic Com. Rep.) did annual walk through and identified problem trees that will be worked on. Bob DeNigris spoke about landrent which will increase in the Spring. More information on this will be available at the February Meeting.

ELECTIONS: TOWN OFFICERS

All three Town Officers were unanimously re-elected.

GRAPEVINE/POISON IVY/HONEYSUCKLE/ETC.: After some discussion, it became clear that the general feeling was that the town does not want to deal with this. Barbara Mondzelewski motioned that we do not take action on vines on common grounds. The motion was unanimously accepted.

BUDGET/ASSESSMENT COMMITTEE:

Betty Solway Smith was elected to this committee.

USAGE OF STATE FUNDS:

About \$12,000 is available for Capital Projects. Possible ideas were discussed i.e. footpath to creek area, bridge on Orchard Road by Kate Downs house, footpaths, light at Harvey and Sconset. Lisa agreed to call and find out how funds may be used.

MEMORIAL GARDEN: Jack Brandner, Chair

The dead plants were replaced in the garden. There is presently about \$120 in the present Memorial Fund.

CIVIC COMMITTEE: Harold Kalmus and Charlie Till

Steet signs are on order. Woodland Road project has been awarded to Wayne Knotts and work to be completed by snow season.


NEW BUSINESS:
